2 ENROLLED, An Act,

3 Relating to Jefferson County; to prohibit more than
4 one adult or unrelated juvenile criminal sex offender from
5 residing in a residence; to provide that no more than one
6 adult criminal sex offender may reside in an apartment complex
7 unless there is a distance of at least 100 yards from the
8 residence of any other offender; to subject the owner or
9 lessee who permits a violation to a civil penalty; and to
10 provide exceptions.

11 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

12 Section 1. This act shall only apply in Jefferson
13 County.

14 Section 2. (a) No adult or unrelated juvenile
15 criminal sex offender may establish a residence or other
16 living accommodation in a residence where another criminal sex
17 offender whose name appears on the Jefferson County Sheriff's
18 official published sex offender list resides.

19 (b) No more than one adult criminal sex offender
20 whose name appears on the Jefferson County Sheriff's official
21 published sex offender list may establish residence or other
22 living accommodations in any apartment complex unless there is
23 a distance of 100 yards or more from the residence in the
24 apartment complex of any other adult criminal sex offender.

1 (c) The owner or lessee of the property who
2 knowingly, willingly, or intentionally permits a violation of
3 subsection (a) or subsection (b) shall be subject to a civil
4 penalty of five thousand dollars (\$5,000) for each violation.
5 When collected, those penalties shall be equally distributed
6 to the Birmingham Police Department Sex Offender Unit and the
7 Jefferson County Sheriff's Department Sex Offender Unit.

8 (d) An owner or lessee of property shall not be in
9 violation of subsection (a) or subsection (b) if the sex
10 offender is the spouse or child of the owner or ~~lessee~~ lessor
11 or if the spouse or child is the owner or lessee of the
12 property.

13 (e) An owner of property shall not be in violation
14 of subsection (a) or subsection (b) where the application for
15 a lease or the lease itself provides a signed statement by the
16 lessee that the lessee is not a convicted sex offender.

17 Section 3. This act shall become effective on the
18 first day of the third month following its passage and
19 approval by the Governor, or its otherwise becoming law.
